**4. Conclusions on new features of Ph.D Dissertation**

**4.1. As for the theoretical perspectives:**

*Firstly*, introducing the concepts of essential goods, clearly analyzing the characteristics of essential goods specifically relating to electricity and gasoline, and clarifying the impacts of prices of these goods on consumer price index;

*Secondly*, outlining the concepts of the State price management on essential goods, thereby clearly defining management subjects, management objects and management principles; moreover, especially generalizing 3 basic contents of the State price management of essential goods as well as factors affecting the State price management of these goods;

*Thirdly*, mapping out a system of 6 evaluation criteria and determining the evaluation model of the State price management of essential goods;

*Fourthly*, summarizing and systemizing of experiences on the State price management of essential goods, particularly electricity and gasoline in the world, thereby, introducing lessons for Vietnam in the State price management of electricity and gasoline.

**4.2. As for the practical perspectives:**

*Firstly*, clarifying general contents about two particularly important and essential commodities in Vietnam, namely as electricity and gasoline, as well as analyzing the impacts of electricity and gasoline prices on consumer price index in Vietnam;

*Secondly*, focusing on analyzing the State management situations of electricity and gasoline prices in Vietnam in recent years in the groups of the State management contents in accordance with the characteristics of each commodity, thereby, capturing the comprehensive perspectives of the current situations of the State management on electricity and gasoline prices in Vietnam;

*Thirdly*, comprehensively assessing the strengths and weaknesses as well as the causes - it is considered as an important basis for proposing recommendations to fulfill the State management of electricity and gasoline prices in Vietnam in the coming time;

*Fourthly*, introducing specific viewpoints and orientations in the State management on electricity and gasoline prices in Vietnam in the coming time in accordance with the national general orientations and the worldwide development trends;

*Fifthly*, analyzing and interpreting specific solutions and recommendations in each content group of the State price management on two essential goods, i.e. electricity and gasoline in order to complete the State price management on essential good in general and on electricity and gasoline in particular. These solutions and recommendations are outlined in close relation with the basic characteristics of two essential goods as well as in line with the market management trends.
