**5. New contributions of the thesis are as follows**

**5.1. From theoretical perspective**

- Through an overview of domestic and foreign scientific works, the thesis has considered issues related to financial security of state-owned economic groups, thereby identifying gaps research and raise key questions to be answered.

- The thesis systematizes and clarifies some basic theories on financial security of state-owned economic groups, which clearly outlines the issues of concept, the system of reflection indicators, the factors affecting financial security of state-owned economic groups.

- The thesis has synthesized the experience of ensuring financial security of a number of state-owned economic groups in the world, thereby drawing reference lessons for state-owned economic groups in Vietnam.

**5.2. From practical perspective**

- Based on secondary data sources of 09 state-owned economic groups in Vietnam, the thesis has analyzed the outstanding issues of financial security of state-owned economic groups in Vietnam. The South in the period of 2013 - 2020. In which, the aspects of financial security studied by the thesis include: (i) financial stability, (ii) financial safety.

- The thesis has applied a quantitative model to assess and forecast the influence of factors on financial security of state-owned economic groups in Vietnam. The test results show that the financial security of state-owned economic groups in Vietnam is influenced by solvency, profitability, and cash flow. Based on the analysis results, the thesis draws some evaluations on the achievements as well as points out the limitations that still exist in the financial security of state-owned economic groups in Vietnam as well as the causes of the problem. causes of the above problems.

- The thesis proposes a number of solutions to ensure financial security of state-owned economic groups in Vietnam. The thesis also makes some recommendations to the Government to make financial information transparent of state-owned economic groups in Vietnam as well as to raise awareness about ensuring financial security of corporations. economic groups with state capital in Vietnam, thereby improving the ability to ensure financial security of state-owned economic groups in Vietnam.
