5. Summary of new conclusions of the thesis

5.1. In terms of practice

Firstly, the thesis has synthesized national and foreign researches related to the subject and made comments on published works. From there, it is possible to identify the gaps that need to be improved, the contents that need to be studied in depth, and determinate the appropriate research objectives and subjects.

Secondly, the thesis establishes a theoretical framework on criteria to evaluate the results of FDI attraction in terms of implementing new generation FTAs, including: group of criteria on capital size and average capital size of a project; group of criteria on FDI structure; group of criteria reflecting the efficiency of capital use.

Thirdly, the thesis analyzes the factors affecting FDI attraction in terms of implementing new generation FTAs into a country, including 6 factors: (1) politics, (2) economy, (3) society, (4) technology, (5) law, (6) integration.

Macroeconomic managers, researchers and other interested people can refer to this thesis to gain a deeper understanding of FDI attraction in terms of implementing new generation FTAs from the point of view of recipients of investment, especially with a developing and strongly integrated country as Vietnam.

5.2. In terms of practice

Firstly, on the basis of analyze and evaluation of the current situation of FDI attraction into Vietnam in the context of implementing new generation FTAs through a system of evaluation criteria and influencing factors, the thesis has pointed out positive results as well as limitations and causes. The comments and evaluation of the thesis will help researchers and macroeconomic managers

in Vietnam have a more global, complete and perfect view of FDI attraction in Vietnam in the period of strongly integration into the world economy.

Secondly, from that real situation and the experience of FDI attraction in the context of implementing new generation FTAs of some typical countries in the world that can be applied to Vietnam, the thesis proposes the following views, solutions for Vietnam to attract more strongly and effectively and increase effectively FDI inflows into Vietnam.

Third, the good results of the thesis can be considered as a reference for State management agencies, business associations, departments, FDI enterprises and national enterprises. The thesis is considered also a reference for teaching, learning activities and scientific research activities for students majoring in economics in general and majoring in finance in particular at universities and colleges.
